Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND, OR ACT TEST REGISTRATION, IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT, OR ACT TEST REGISTRATION, WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY. The "ACT Summer Passport Sweepstakes" (the "Sweepstakes") is only open to entrants who, as of the date of entry, are permanent legal residents of the forty-eight (48) contiguous United States of America (i.e., excluding Alaska and Hawaii) and the District of Columbia, at least fourteen (14) years old, and in the ninth (9th), tenth (10th), eleventh (11th), or twelfth (12th) grade, or received a high school diploma in 2023 (or, if home schooled, in the equivalent of ninth (9th), tenth (10th), eleventh (11th), or twelfth (12th) grade). ENTRANTS WHO ARE MINORS MUST GET THEIR PARENT OR LEGAL GUARDIAN'S PERMISSION PRIOR TO PARTICIPATING IN THE SWEEPSTAKES. An entrant must satisfy all of the foregoing eligibility requirements in order to participate in the Sweepstakes. The Sweepstakes is void outside the eligible Sweepstakes territory, and where prohibited or restricted by law. Employees, officers and directors of ACT, Inc.  - Week 6 Entry Period: 10:00 a.m., CT on July 12, 2023 and ends at 9:59 a.m., CT on July 14, 2023.
 - Week 7 Entry Period: 10:00 a.m., CT on July 17, 2023 and ends at 9:59 a.m., CT on July 21, 2023.
 - Week 8 Entry Period: 10:00 a.m., CT on July 26, 2023 and ends at 9:59 a.m., CT on July 28, 2023.

The Sweepstakes will end at 9:59 a.m. CT on July 28, 2023. Sponsor's computer is the official timekeeping device for the Sweepstakes.

3. HOW TO ENTER; ENTRY REQUIREMENTS.

- vi. Week 6 Entry Requirements. During the Week 6 Entry Period, eligible entrants may enter the Sweepstakes by (1) uploading a qualifying photo or video of you on Instagram that shows what high school club or extracurricular activity you love. An eligible entrants' r photo or video must (i) conform to the requirements in Section 3(b), and contain the tags and hashtags described therein.
- vii. Week 7 Entry Requirements. During the Week 7 Entry Period, eligible entrants may enter the Sweepstakes by (1) commenting on the ACT Instagram week 7 giveaway post one thing you're adding to your resume after this summer, (2) liking the Instagram post, and (3) following the ACT Student Instagram account (@actstudent).
- viii. Week 8 Entry Requirements. During the Week 8 Entry Period, eligible entrants may enter the Sweepstakes by (1) registering for the September ACT My Journey: Connection virtual webinar at act.org/myjourney, (2) liking the Instagram post, (3) following the ACT Student Instagram account

- (@actstudent) and (4) commenting an emoji once you've registered for the September ACT My Journey: Connection virtual webinar on the week 8 ACT Instagram giveaway post.
- b. For Entry Photo/Video Requirements. www.Instagram.com. Creating an Instagram account is free. Each entry photo or video must meet the following requirements, compliance with which shall be as determined by Sponsor in its sole discretion:
- i. IF THE ENTRANT IS A MINOR, THE ENTRANT MUST GET THEIR PARENT OR LEGAL GUARDIAN'S PERMISSION PRIOR TO POSTING AN ENTRY PHOTO OR VIDEO OR OTHER SOCIAL MEDIA POST.

- iv. - vi. - viii. To the extent that a third party shot or helped with the production of an entry, the entrant must be able to provide on request all appropriate clearances, permissions and releases from that third party's participation in the creation or production of the entry and location releases for all recognizable locations. In the event an entrant cannot provide all required releases, Sponsor reserves the right, in its sole discretion, to disqualify the applicable entry or seek to secure the releases and clearances for Sponsor's benefit.
- ix. By submitting an entry, the entrant (and a minor entrant's parent or legal guardian) represents and warrants that the submitted entry complies with all requirements of these Official Rules, including those set forth in this Section 3(b), and will indemnify, defend and hold Sponsor and all Sweepstakes parties harmless from and against any breach of such representation and warranty.

Proof of posting to Instagram will not be deemed to be proof of receipt of entry by Sponsor or its designees. Normal Internet access and usage charges imposed by entrant's online service will apply. Failure to submit all required information and submissions in the manner required in these Official Rules may result in disqualification. ENTRY MATERIALS WILL NOT BE ACKNOWLEDGED OR RETURNED, AND, IN FACT, MAY BE DESTROYED. DO NOT SUBMIT ANY IRREPLACEABLE OR ONE-OF- A-KIND ENTRIES.
- 4. AGREEMENT TO OFFICIAL RULES AND DECISIONS. By participating in the Sweepstakes, each entrant (and a minor entrant's parent and legal guardian) fully and unconditionally agrees to be bound by and

Odds of winning a prize depend on the number of eligible entries received by Sponsor in the Sweepstakes during each Entry Period.
