ACT has offered the choice of online or paper-pencil formats for ACT School Day and District Testing programs to high school juniors and seniors since 2015.

Familiarity for Students



- PreACT online administration gives students a streamlined experience on the same platform as the computer-based ACT test used by ACT State and District Testing.

- PreACT online saves time by removing orders and returns of paper materials reducing reliance on shipping, handling, and storage.
- For record keeping an electronic copy of the answer booklet will be provided which is a more sustainable and shareable record of achievement.
- For administration we are aligning paper-pencil and online testing in a single administrative platform so educators can easily decide which mode is right for each student.

Will PreACT Assessments Be Updated to Reflect the ACT Enhancements?

New PreACT blueprints will align with the enhanced ACT. We will roll out the new blueprints in spring 2026 (along with the change to the new Composite score) for PreACT 9 Secure and PreACT Secure when the State and District Testing ACT changes roll out. The PreACT 8/9 and PreACT changes start in fall 2026.

Science remains as part of the PreACT test battery for all customers until new blueprints are rolled out for each specific product. Then, if schools or districts (not under a state contract) wish to take PreACT with or without science to mimic what they are offering for the ACT, students won't complete the science section. It won't affect scores, since Composite scores will be calculated based on English, math and reading only. Students won't get a science or STEM score, and it will show up as " - - " on score reports.
