
ACT Certified Educator (ACE) Program Vision

Overview of the Program

ACT is the central certifying body issuing credentials to qualified candidates. The credential can be earned in any and all of the four ACT subject areas plus Writing, as well as an ACT Basics certification that cover the understanding of the fundamental aspects of the ACT test (general test procedures and administration, *not* specific to any subject area).

The program requires a qualification assessment to ensure content expertise in the appropriate subject area (exception for the Basics course). The understanding of content is critical to be able to teach; however, the ACT believes the ability to understand and utilize teaching and learning strategies is what makes effective educators. To validate understanding of content and pedagogy, ACT will administer a certification exam at the end of the training. Claims of teaching ability will be delivered by ACT to certification holders to share.

ACT® Certified Educator Program

ACT Certified Educator Courses

Certification Courses

Certification requires candidates to be present during training sessions. The ACT Certified Educator–Basics and ACT Certified Educator–Writing courses are one day in length, while the other subject-specific courses consist of two days of training.

ACE Certification exams will take place at the end of each training course.

The curriculum presented at each course will consist of the following:

ACT Basics (9 Hours)*

- Registration
- Test preparation resources
- What to expect on test day
- Checking in
- Required materials
- Mental preparedness
- Test-taking soft skills

**All candidates are strongly advised to complete the Basics course, regardless of whatever subject-specific certifications they wish to obtain. It is a foundational program that promotes the development and use of learner centered skills and the standards of professionalism required of ACT Certified Educators, regardless of subject area.*

- All Writing content from Career and College Readiness Standards (CCRS)
- Teaching techniques and strategies for CCRS.
- Coaching skills.
- Use of educational resources (e.g., ACT Academy) for remediation and practice





ACE-English - Learning Objectives (examples)

Individualized Tutoring

- Candidate will make up a simpler version of a question when a student demonstrates an error/misconception in order to highlight an underlying principle leading to a correct response

Identify and Recommend Strategies

- Candidate will differentiate between easier and harder questions within content categories within the English language test framework and make recommendations to students about pacing themselves.


Understand Test Structure and Content

- Candidate will correctly identify the skill target of a given ACT English item, using appropriate language of the discipline (e.g., “subject-verb agreement,” “misplaced modifier,” “wordiness”).

ACT Certified Educator–English



The certification holder has completed an ACT Certified Educator–English training program and passed an assessment that measures ability to tutor students on the English section of the ACT Test. The training and assessment include but are not limited to: understanding the ACT English Test structure and content; understanding and recommending test-taking strategies related to ACT English content; and providing individualized tutoring. By completing the ACT Certified Educator–English training and passing the assessment, the certification holder has met the standards set forth by the ACT Certified Educator program and has demonstrated sufficient knowledge to tutor students who are preparing for the ACT English Test.

CRITERIA TO EARN THIS BADGE

The certification holder has met the following requirements.

- Read and agreed to the ACT Certified Educator Code of Ethics and Professional Conduct.
- Met or exceeded the ACT Certified Educator qualification standard for the ACT English Test, indicating a level understanding of the content of the ACT English Test sufficient to provide tutoring services in the subject area.
- Completed an 18-hour ACT Certified Educator program relevant to the ACT English Test. The training includes the provision of individualized tutoring related to the content of the ACT English Test; recommending relevant test-taking strategies; and providing tailored tutoring related to the specific content of the ACT English Test.
- Passed an ACT Certified Educator–English examination, indicating knowledge of individualized tutoring strategies and techniques, as well as specific strategies related to the content of the ACT English Test that are needed to prepare students for the Test.

The credential holder is authorized to use the ACE–E designation. The certification will be valid for 2 years from the date of award.

The ACE–E certification holder is bound by the standards of ACT related to the protection of ACT's intellectual property. The ACE–E certification holder is required to demonstrate the highest levels of ethical behavior and professionalism as described in the ACT Certified Educator Code of Ethics and Professional Conduct. The certification is subject to revocation if ACT receives notice that those ethical standards are violated.
